However, bidding documents shall still be available for purchase after the pre-bidding conference. Deadline for purchase of bidding documents is 5 days before the bid opening date.

Bidding will be conducted through open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the NEA Memorandum No. 2017-019: Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives, IRR – RA 10531 (2017).

Prospective bidders are required to have a stable internet connection during the conferences and the BAC shall not be liable for any unexpected disruption due to poor/unstable signal which may cause prospective bidders' inability to catch up with the conference. All Bid Proposals shall be accepted at the BAC Office two (2) hours before the scheduled bid opening conferences, otherwise, shall be disqualified.

BATELEC II reserves the right to accept or reject any and all bids, to declare failure of bidding, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s. BATELEC II likewise assumes no obligation whatsoever to compensate or indemnify any bidder or winning bidders, as the case may be, for any expenses or loss that said party(ies) may incur in its participation in the pre-bidding and bidding process nor does it guarantee that an award will be made.
