Prospective bidders must first send a **Letter of Intent** to SURSECO-I and shall secure an **Accreditation** from the Cooperative's **Bids and Awards Committee (BAC)**. Interested bidders may obtain the list of Documentary Requirements for Eligibility and Bidding Forms upon payment of the Accreditation Fee of One Thousand Pesos (PhP 1,000.00) and the **non-refundable** Bidding Documents Fee per lot through over-the-counter payment at the SURSECO-I Main Office Teller.

The Bid must be accompanied by a **BIDDER'S BOND** in the form of CASH or **MANAGER'S CHECK** in the amount equal to **2% of the BID PRICE**. No other form of bid bond will be accepted. The bidder's bond is to be enclosed in the sealed envelope containing the bid. All prospective bidders must be **VAT-registered**.

Attendance to the Pre-Bidding Conference on 6 October 2023 is optional. However, all matters discussed and agreed upon by the attending parties are final and irrevocable. All bids and other documents shall be submitted in a sealed envelope, properly labeled and addressed to the Chairperson, Bids & Awards Committee, SURSECO-I, and shall be submitted on or before the Opening of Bids. All bids, together with the required eligibility documents, shall only be opened during the Opening of Bids on 16 October 2023. Both the Pre-Bidding Conference and the Opening of Bids shall be held at the SURSECO-I Main Office in San Fernando, Bislig City, Surigao del Sur.

Consistent with its Procurement Guidelines/Policies and NEA issuances, SURSECO-I reserves the right to reject any and all bids, declare a failure of bidding, or not award a contract for justifiable grounds.
