INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE FOLLOWING BIDDING ACTIVITIES OF OMECO:

- A. Public bidding for the Procurement of Services of a Health Care Service Provider for C.Y 2023 2024 (OMECO PAP No. BAC 23 018)
 - The Occidental Mindoro Electric Cooperative, Inc., (OMECO) through the General Fund intends to apply the sum of Three Million Five Hundred Ten Thousand Pesos (PHP3,510,000.00), inclusive of all applicable taxes and fees being the Approved Budget for the Contract (ABC) to payments under the contract for the bid of services of a Health Care Service Provider. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 - Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531 and Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
 - Interested bidders may obtain further information from OMECO Bids and Awards Committee (OMECO-BAC) and inspect the Bidding Documents at the address given below during *Monday to Friday from 8:00 AM to 5:00 PM (except Holidays)*.
 - 4. A complete set of Bidding Documents may be acquired by interested bidders from *October 13*, 2023 (office hours 8:00 AM to 5:00 PM) until October 20, 2023 at 9:00 AM from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of *Five Thousand Pesos* (PHP 5,000.00).
 - Bidders may also acquire the electronic copy of the complete set of Bidding Documents via official email address of BAC: omeco2018bac@gmail.com, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.
 - The OMECO will hold a Pre-Bid Conference on October 20, 2023, Friday at 9:00 AM at the OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.
 - Attendees to the Pre-Bid conference are only the prospective bidders who have bought bid documents, or their authorized representative (duly notarized).

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid; however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

The bidder may opt to attend the pre-bid conference either face-to-face or via virtual conference using the ZOOM application or both.

6. Bids must be duly received by the BAC Secretariat at the address below on or before **November 03, 2023**, **Friday at 9:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

Bid opening shall be on **November 03, 2023, Friday at 10:00 AM** at OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

- Bidding will be conducted through Sealed Canvass using a non-discretionary "pass/fail" criterion. Bidding is open to all OMECO's Accredited and Non-Accredited Suppliers, provided that Non-Accredited Suppliers must submit required accreditation documents listed in the Accreditation Check List Requirement and Accreditation Fee amounting to Three Thousand Pesos Only (Php 3,000.00) as provided.
- 4. Request for Quotation (Sealed Canvass) is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the

laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
