Delivery Period:

For Items I and V: 50% delivery within thirty (30) calendar days and full delivery within sixty (60) calendar days upon receipt of Purchase Order.

For Items II, VI, and VII: Thirty (30) calendar days upon receipt of Purchase Order.

For Item III: 384 units delivery within fifteen (15) calendar days, and full delivery within thirty (30)

calendar days upon receipt of Purchase Order.

For Item IV: 480 units delivery within fifteen (15) calendar days and full delivery within thirty (30)

calendar days upon receipt of Purchase Order.

All Eligibility Statement and Screening, Bid Security, Performance Security, Warranty Security, Pre-bidding Conference(s), Evaluation of Bids, Post Qualification, Award of Contract and other particulars relative to the bidding shall be governed by the pertinent provisions of RIRR of R.A. 10531.
