5. Bids must be submitted to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security.
6. The Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the implementing Rules and Regulation (IRR) of the Republic Act (RA) 10531.
7. Interested Bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below during office hour, Monday to Friday before the opening of Bids.
