INVITATION FOR NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS)

Supply of 15 kV Line Materials, House Wiring Materials, Labor and Freight and Handling for SEP Project GAA 2022

- 1. In view of the two-failed biddings, KALINGA-APAYAO ELECTRIC COOPERATIVE, INC. (KAELCO), intends to apply the sum of FIFTY ONE MILLION SIX THOUSAND THREE HUNDRED FORTY ONE PESOS & 09/100 (P51, 006,341.09) being the Approved Budget for Contract (ABC) under Bid Ref. No. 06-2023 for the Supply of 15 kV Line Materials, House Wiring Materials, Labor and Freight and Handling for SEP Project GAA 2022. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. KAELCO, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable contractors for the mentioned SEP Project. Bidders should have completed, within the last three (3) years from date of submission and receipt of bids, a contract similar to the Project including contracts awarded but not yet started, if any. The description of eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
- 3. This project is Negotiated Procurement due to two (2) failed biddings pursuant to Section 53.1 of R.A. No. 9184 and its Revised Implementing Rules and Regulations.
- 4. The BAC will engage in negotiations with a sufficient number of qualified contractors to ensure effective competition. The selection of the successful bidder shall be based on the best offer of the technical and financial requirement that will be submitted on specified date pursuant to Annex "H", Sec. 1.b.iv of the Revised IRR of RA 9184.

- 7. Bidders who have already bought the bidding documents during the last failed biddings need not pay the amount of non-refundable fee of Fifty Thousand Pesos (P50, 000.00) for the Negotiated Document.
- 8. Bidding is restricted to Filipino citizens, sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

9. Bids must be submitted in sealed envelopes, labeled as "Negotiated Documents", with the title of the procurement project, name of the Bidder, address of the Bidder, and contact details of the bidder, addressed to the BAC Chairman at the address provided below.

- 10. All Proposals shall contain the Eligibility and Technical Documents, as well as the financial documents prescribed in the Negotiated Documents. All the Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the Instructions to Bidders (ITB) 3.14.3.
- 11. Bids will be opened in the presence of the bidders or their authorized representatives who choose to attend at the address mentioned. Late bids shall not be accepted.
- 12. KAELCO reserves the right to accept or reject any and all bids, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. In instances, that may arise and not specifically mentioned herein, KAELCO shall resolve bidding issues by resorting to and applying the pertinent provisions of RA 9184 and its Revised Implementing Rules and Regulations
