**INVITATION TO BID FOR SUPPLY, DELIVERY,
INSTALLATION, TESTING, AND COMMISSIONING OF 1,022
50WP PHOTOVOLTAIC SOLAR HOME SYSTEMS FOR PV
MAINSTREAMING PROJECT UNDER THE TOTAL
ELECTRIFICATION PROGRAM**

1. The Northern Davao Electric Cooperative, Inc. through the Locally Funded Projects – Total Electrification Program 2022 (LFP – TEP 2022) intends to apply the sum of Php 26, 468,982.40 being the Approved Budget for the Contract (ABC) to payments under the contract for *NORDECO, Inc. PV Mainstreaming Project 2023*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 2. The *NORDECO, Inc.* now invites bids for the *Supply, Deliver, Installation, and Commissioning with warranty and spares for 1,022 50Wp Prepaid Solar Home Systems (SHS) with Lithium-ion Battery*.¹ Delivery of the Goods is required by *eight (8) months from issuance of Notice to Proceed*. Bidders should have completed, *within three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
- Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from *NORDECO Bid and Awards Committee (BAC) Secretariat* and purchase the Bidding Documents at the address given below, *Monday to Friday at 8:00am until 5:00pm*.
 5. A complete set of Bidding Documents may be acquired by interested Bidders on *Thursday, November 16, 2023*, from the address below *upon payment of non-refundable applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos Only (Php. 25,000.00)*.

6. It may also be downloaded free of charge from the website of **NORDECO, Inc. and NEA**, provided the Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The **NORDECO, Inc.** will hold a Pre-Bid Conference² on *November 23, 2023, 9 o'clock in the morning*, at *Amacio Hall, Tipaz Office, Tagum City, Davao del Norte*, which shall be open to prospective bidders who purchased the bidding documents.
8. Bids must be duly received by the **NORDECO, Inc.** BAC Secretariat at the address below on or before *December 6, 2023, 9 o'clock in morning*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on *December 6, 2023, 9 o'clock in the morning* at *Amacio Hall, Tipaz Office, Tagum City, Davao del Norte*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. The details of the items to be bid and instructions to bidders are contained in the Bidding Documents which would be made available upon payment of the above specified non-refundable Bid Documents Fee.
10. The **NORDECO BAC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
