

**INVITATION TO APPLY FOR ACCREDITATION AND TO BID**

1. The QUIRINO ELECTRIC COOPERATIVE (QUIRELCO), through its General Fund, intends to apply the sum of Seven Hundred Twenty Thousand Pesos (Php 720,000.00), inclusive of all taxes, being the Approved Budget of the Contract (ABC) for the Supply and Delivery of kiloWatt-hour (kWh) Meter Covers/Boxes of QUIRELCO to wit;

2. Bids received in excess of the ABC shall be automatically rejected during the Bid Opening.
3. QUIRELCO now invites bidders for the Supply and Delivery of kiloWatt-hour (kWh) Meter Covers/Boxes. The description of an eligible bidder is contained in the Bidding Documents.
4. Bidders should have satisfactorily conducted a Supply and Delivery of kiloWatt-hour (kWh) Meter Covers/Boxes project/s within the last three (3) years as of the date of submission and receipt of bids or a contract similar to the project to be bid.
5. Bidding will be conducted through Sealed Canvass/Bid procedure. Failure to submit the required document under the bidding documents or the submission of a document which does not comply with the requirements shall be rated "failed".

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 7. Late bids shall not be accepted. Bid Opening will be on November 28, 2023, 9:00 A.M.
9. QUIRELCO Bids and Awards Committee reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
