CEBU III ELECTRIC COOPERATIVE, INC. (CEBECO III) through its Bids and Awards Committee (BAC), hereby invites all interested suppliers, authorized franchise dealers and contractors for the procurement, supply and delivery of distribution transformers for 2023 Capital Expenditures (CAPEX) Projects Implementation.

1. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
2. A Single-Stage: Two-Envelope Bidding Procedure is to be used to evaluate the technical responsiveness and the Bidder’s qualifications before opening the price proposal.
3. The prospective bidder must have completed a Single Largest Completed Contract (SLCC) similar to this project within the last five (5) years prior to the bid opening. The value of such a contract, adjusted to current prices using the National Electrification Administration Price Index, must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC)
4. The presence of the bidder during the Pre-bid Conference is Optional.
5. A complete set of bidding documents may be obtained from the BAC Secretariat upon payment of a non-refundable bidding fee. A copy of the bidding documents will be provided via e-mail.
6. Bids that exceed the Approved Budget for the Contract (ABC) will be automatically rejected at the time of bid opening.
