# 1. APPROVED BUDGET OF THE CONTRACT (ABC)

#### 2. OBJECTIVE OF THE SPECIAL AUDIT

The objective of the special audit is to obtain reasonable assurance as to whether the amount with abnormal balances in financial statements are accurate, thereby enabling the auditor to express an opinion on whether the financial statements are prepared, in all material respects, in accordance with an applicable financial reporting framework and in compliance with the laws and regulations.

- b. Express recommendation as to reasonableness of the financial statements in all material respects.
- c. Provide adjusting entries on the reconciled accounts.
- d. In addition to the special audit report, the auditors will prepare a Management Letter on the following:

- Identify specific deficiencies and areas of weakness in systems and controls and make recommendations for improvement.
- Communicate matters that have come to their attention during the special audit which might have a significant impact on the sustainability of the organization.

#### 5. QUALIFICATIONS

## **Qualifications of the Audit Firm**

#### 7. TERMS OF PAYMENT

15 % upon receipt of approved Notice to Proceed

60 % upon receipt of report on 1.2 to 1.7 and 1.10

25 % upon submission of 1.1, 1.8 and 1.9, and issuance of Certificate of Completion from Enduser

#### 8. LIQUIDATED DAMAGES

a. In the event that the Service Provider fails to satisfactorily deliver any or all of the goods and/or perform the services within the specified period(s) mentioned in the Agreement, inclusive of duly granted time extensions, if any, the Procuring Entity shall have the right, without prejudice to other remedies under the Agreement and applicable laws, to -deduct from the Contract Price, as liquidated damages, one-tenth (1/10) of one (1) percent of the cost of the unperformed portion for each day of delay until actual delivery or performance.

b. If the total sum of liquidated damages reaches ten percent (10%) of the total contract price, the Procuring Entity may rescind the contract and impose appropriate sanctions in addition to the liquidated damages to be paid.

#### 9. RESERVATION CLAUSE

The Camarines Sur II Electric Cooperative (nc. (CASURECO II) reserves the right to reject any quotations, annul the procurement process, and reject all quotations at any time without incurring any liability to the affected service provider.
