1. Further details relative to the aforementioned project are outlined in the Bid Documents to be provided to all interested bidders upon purchase of the Bid Documents on the schedule and at the venue stated above. The cost of bid documents is not refundable.
2. The Pre-Bid Conference will be held via face-to-face or Zoom as the case may be. A Zoom link will be provided to those who will opt to join via Zoom. Only Bidders who bought bidding documents are allowed to attend the Pre-Bid Conference. For the Bid Opening, it will be conducted face-to-face.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the NEA Memorandum 2017-019, otherwise known as the "Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017)."
4. All bids submitted must be accompanied by a bid security payable to ISELCO-I in the amount equivalent to two percent (2%) of the Approved Budget for the Contract (ABC). Bids and Bid Securities shall be valid for a period of one hundred twenty (120) calendar days from the date of the opening of bids.
5. Bid proposals must be VAT-inclusive. Sealed Eligibility Requirements, Technical, and Financial Envelopes must be submitted to the BAC Secretariat at the BAC Office, ISELCO-I, Victoria, Alicia, Isabela, **on or before the scheduled Bid Opening (January 22, 2023), until 10:00 AM**, during which said envelopes for eligibility requirements and proposal for the respective item/s will be opened and read in the presence of the bidder's representative. **Late bids shall not be accepted.**
