4. Interested Bidders are required to register for accreditation with the BAC Secretariat through payment of a non-refundable Accreditation Fee of Php 5,000.00. Certificate of Accreditation will be valid for one year.
5. Bidders should have satisfactorily completed within the last five (5) years as of the date of submission and receipt of bids a single largest supply and delivery of materials that is similar and at least equivalent to the ABC.
6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/ fail" criterion. Failure to submit the required document under the bidding documents or the submission of a document which does not comply with the legal formalities shall be rated "failed".
7. The Bids and Awards Committee will hold a Pre-Bid Conference (Physical and Virtual) on the date specified in the schedule of activities. Only those who purchased the Bidding Documents, or their authorized representative with duly notarized undertaking will be allowed to participate in the Pre-Bid Conference.
8. Bids must be submitted to the address below. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids will not be accepted.
9. The QUIRELCO Bids and Awards Committee reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
