
1. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 otherwise known as the "Government Procurement Reform Act" and the NEA Memorandum No. 2017-019 on the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
2. Interested bidders may obtain further information from the ZAMCELCO BAC Secretariat Office and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM.
3. A complete set of Bidding Documents may be acquired by interested Bidders on January 23, 2024 (Tuesday) to February 11, 2024 (Sunday) from the address given below or sent through electronic email upon payment of the applicable fee to be deposited at ZAMCELCO's Bank of Commerce Account No. 029-00-001214-7 and presentation of the deposit slip to the BAC Secretariat.

4. The Bids and Awards Committee will hold two Pre-Bid Conferences for the bidding. The first Pre-Bid Conference will be on January 24, 2024 (Wednesday) 09:00AM Video Conference to accommodate queries and site visit. The second Pre-bid Conference will be on January 30, 2024 (Tuesday) to February 11, 2024 (Sunday) to allow presentation of bidder's proposed design. Only bidders who purchased the Bidding Document shall be allowed to participate in the Pre-bid Conference and raise or submit written queries or clarifications.
5. Bids must be duly received by the BAC Secretariat through manual submission of two (2) hard copies of their sealed bid at the office address as indicated below on or before the deadline of receipt of bids on the bid opening date. Soft copy of their bids must also be received a day before the bid opening date but the password to be furnished on the bid opening.
6. All Bids shall be opened online and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids.
7. Only those bidders who have bought the bidding documents shall be allowed to participate in the Submission and Opening of Bids.
8. ZAMCELCO reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to the awarding of contract, thereby without incurring any liability to the affected bidder or bidders.
