The proposal of bidders found eligible will be opened and read on the same date and time in the presence of the Bidders or Bidder's representatives who choose to attend, otherwise, they will be returned unopened to ineligible bidders.

Delivery of all electrical materials shall be thirty (30) calendar days upon receipt of Notice to Proceed and Purchase Order.
