THE CONSTRUCTION AND INSTALLATION OF SAN ANDRES 20MVA
SUBSTATION, EXTENSION OF 69KV LINE AND CONSTRUCTION OF SAN
ANDRES SATELLITE OFFICE**

TARELCO I invite eligible bidders to bid for the Construction and Installation of San Andres 20MVA Substation, Extension of 69KV Line and Construction of San Andres Satellite Office. **PCAB License must be Medium A License Category B Electrical Works.**

Approved Budget for the Contract is Seventy-Nine Million Three Hundred Sixty-Five Thousand Four Hundred Eighty-Four Pesos (₱ 79, 365, 484.00). The source of fund for this procurement is the General Fund but to be recovered from Reinvestment Fund for Sustainable Capital Expenditures (RFSC) through CAPEX Application. Quoted price must be inclusive of VAT. **The project must be completed within one hundred eighty (180) calendar days commencing upon receipt of Notice to Proceed.**

Potential bidders must apply for accreditation and pay an **accreditation fee of Two Thousand Pesos (P2, 000.00)** before they are allowed to participate in the bidding process. The accreditation requirements shall be provided by the BAC Secretariat. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee amounting to **Fifty Thousand Pesos (₱ 50, 000.00) for the cost of bidding documents.**

A complete set of bidding documents may be purchased starting **08 April 2024 until 4:00 P.M. of 18 April 2024 (excluding holidays and weekends)** by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference shall be held on **19 April 2024 2:00P.M.** at the TARELCO I Main Office Board Room. Questions and clarifications regarding the bid documents must be submitted on or before **18 April 2024. Questions and clarifications not submitted on or before the given date shall not be entertained during the pre-bid conference.**

The Bid Opening shall be held on **02 May 2024 2:00P.M.** in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

Bidding shall be conducted through a public bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017).
