
Pre-bid Conference shall be held on **May 2, 2024 10:00A.M.** at the TARELCO I Main Office MCOO Hall. Questions and clarifications regarding the bid documents must be submitted on or before **May 1, 2024. Questions and clarifications not submitted on or before the given date shall not be entertained during the pre-bid conference.**

The Bid Opening shall be held on **May 14, 2024 2:00P.M.** in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

Bidding shall be conducted through a public bidding procedures using non-discretionary "pass/fail" criterion as specified in the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017).
