Public Bidding for the Supply of Two (2) Units of Boom Truck for Coop Use

**TO ALL PARTICIPATING BIDDERS:**

The Marinduque Electric Cooperative, Inc. (MARELCO) Bids and Awards Committee (BAC) and the Technical Working Group (TWG) hereby issue this Bid Bulletin No. 2024-001-01 as amendments to the initial invitation to bid advertised in the Philippine Daily Inquirer dated April 8, 2024 and was posted in the MARELCO Facebook & Website as well in the NEA website.

Below are the list of significant changes made to the Instructions to bidders and Bid Documents as per result of the Pre-bid conference held last April 16, 2024 and queries received from the bidders.

No.	Queries/Clarification	BAC's Decision/Response
1	Extension of Deadline for Submission of Bids to give ample time for Bidders to comply with the required technical specifications.	Deadline of submission and opening of bids will be on <b>May 8, 2024, 9:00 AM</b> at the MARELCO Conference Room.
2	Invitation to Bid – Bidding Requirements: <i>a. Bidders must be Authorized Dealers of Vehicles</i>	It is agreed to allow bidders whether Authorized Dealers or Vehicle/ Equipment Distributor to participate in the bidding.
3	Option to bid for single item/unit	It is allowed to bid for single item as the basis of awarding is on a per item/unit basis.
4	Bid Security	Bid Security shall be equivalent to 2% of the ABC per lot or to PHP 600,000.00.  If in case the Bidder opt to issue Bid Security in the form of Cash, see below bank details. PNB Account Boac Branch Acct Name: Marinduque Electric Cooperative, Inc. Acct Number: 2477-1000-8056  <i>Note: Deposit slip must be attached on Envelope 2 Folder 1 – Technical Proposal; a. Bid Security</i>
5	Specifications for 11 tons capacity Boom Truck <i>a. Cab-Chassis – at least 18,000-kg. GVWR b. Pole Rack</i>	<i>a. The specifications set by the end user for the Cab-Chassis shall remain as is. b. Both 11 and 6 tons capacity boom truck must have at least 2 pole racks.</i>
6	Pre-Qualification	The bidder may conduct pre-qualification demo via online or onsite at their own expense.
7	Post Qualification	MARELCO personnel shall conduct site inspection at Bidder's Production Plant/Stockyard as part of the post-qualification for the Bidder with the Lowest Calculated Bid, at the Bidder's expense prior to award. This will be composed by 3-5 representatives from Technical Working Group (TWG), End User and Motorpool Section for two days (which includes travel time and inspection)
8	Delivery	Delivery shall be made within 120 days upon receipt of NTP and Purchase Order.
9	Other Technical Specifications	Bidder may offer all other technical specifications not mentioned on the Annex B.
