All bids must be accompanied by a bid security in form of cash, cashier/manager's check in the amount equivalent to two percent (2%) of the Approved Budget Cost.

The Pre-Bid Conference shall be open to all interested parties; however, only those who have purchased the Bidding Documents may participate in the discussion at said conference.

The Pre-Bid Conference, Submission and Opening of Bids shall be held at BISELCO Office, Conference Room, Mabentangen Road, Brgy. Poblacion 6, Coron, Palawan.

Bids received in excess of the ABC shall be automatically rejected at the Bid opening.
