Two (2) copies of the Bid Documents – Eligibility Envelope & Technical Envelope (one original and one copy) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 5.00PM of **MAY 21, 2024**. Late submission shall not be accepted.
