

2. Interested Security Agencies must submit their letter of intent on or before the scheduled Pre-Bid Conference. Only those who submitted the letter of intent shall be allowed to avail the bidding documents. Only the prospective agencies that have purchased the bidding documents are eligible to attend the pre-bid conference. Attendance of the bidders to the pre-bid conference is mandatory.
3. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified on the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives (IRR of RA 10531).
5. Interested Bidders may obtain further information from the Secretariat, Janine S. Nachor/Jean Tita O. Gonzaga and inspect the Bidding Documents at the address and contact details given below during office hours, Monday to Friday before the opening of Bids.
