



**INVITATION TO BID FOR THE SUPPLY OF LABOR AND MATERIALS FOR
CONSTRUCTIONS OF DISTRIBUTION LINE EXTENSION FOR FOURTEEN (14)
SITIOS IN THE MUNICIPALITIES OF LIBMANAN, PAMPLONA, RAGAY,
SIPOCOT AND LUPI, CAMARINES SUR.**

1. The CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I), through the **2024 General Appropriations Act (GAA) Sitio Electrification Program (SEP) Subsidy under the National Electrification Administration's (NEA) 2024 SEP Subsidy** intends to apply the sum of **Twenty-Two Million Eight Hundred Thirty-one Thousand Seven Hundred Sixty-three and Sixty Four Centavos (Php 22,831,763.64)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for Extension of Distribution Line for Fourteen (14) Sitios in the Municipalities of Libmanan, Pamplona, Ragay, Sipocot and Lupi, Camarines Sur. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. CASURECO I now invites bids for the supply of materials, labor, delivery, excavation, clearing and erection/installation of 7.62/0.24kV distribution line for the following:
 - 1) Mambungliw, Udoc, Libmanan, Camarines Sur
 - 2) Kuminan, Caditaan, Ragay, Camarines Sur
 - 3) Makalimas, Bahao, Libmanan, Camarines Sur
 - 4) Pulang Daga, Upper Santa Cruz, Ragay, Camarines Sur
 - 5) Silangan, Upper Santa Cruz, Ragay, Camarines Sur
 - 6) Malabanig, Inandawa, Ragay, Camarines Sur
 - 7) Taban, Cawayan, Libmanan, Camarines Sur
 - 8) Centro A, Alteza, Sipocot, Camarines Sur
 - 9) Zone 1 & 2, La Purisima, Lupi, Camarines Sur
 - 10) Pacolago, Port Junction Sur, Ragay, Camarines Sur
 - 11) Ligao, Tampadong, Pamplona, Camarines Sur
 - 12) Zone 2, Buenasuerte, Lupi, Camarines Sur
 - 13) Zone 5, Kalanob, Bulawan Jr., Lupi, Camarines Sur
 - 14) Zone 1 & 6, Bagacay, Libmanan, Camarines Sur
3. Completion of the Works is required for the duration of one hundred fifty (150) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidders must have a Philippine Contractors Accreditation Board (PCAB) License Category C & D. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations 2016 (Revised IRR 2016) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. Interested bidders may obtain further information from CASURECO I and inspect the Bidding Documents at the address given below from May 30, 2024 to June 17, 2024 from Monday to Friday, 8 am to 5:00 pm (except Saturdays, Sundays & Holidays) & June 18, 2024 from 8:00 am to 12:00 pm.

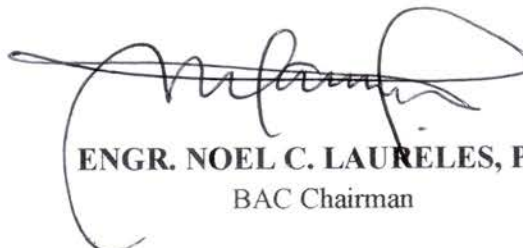

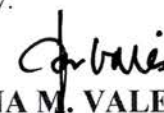

10. Bid Opening shall be at 1:30 pm, June 18, 2024. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
11. All activities related to the bidding process will be conducted at the CAMARINES SUR I ELECTRIC COOPERATIVE, INC. Headquarters, Puro Batia, Libmanan, Camarines Sur.
