This Supplemental Bid Bulletin is being issued to clarify, as well as modify certain items of the Bidding Documents.

1. Response to the queries raised during the Pre-Bid Conference held last May 24, 2024, the following are the clarifications and amendments:

A. REQUEST/QUERY	AMENDMENT/ CLARIFICATION
Based on the presentation, the required lead time was 15 days from receipt of PO, it was asked if full delivery or partial. Consignment basis was not specified in the presentation.	Lots 1 and 2 will be on a <b>CONSIGNMENT</b> basis. Lots 3 and 4 require full delivery.
Since the project will be on Consignment basis and the delivery is staggered, the bidder asked if they will be the one who will offer the schedule of delivery	Delivery schedule for Lots 1 and 2 shall start with an initial <b>50% delivery</b> per item within 15 days upon receipt of Purchase Order, with the remaining delivered <i>in staggered basis</i> depending on ALECO's stock and upon its request. Accordingly, for succeeding requests, delivery shall be made within 7 days.
Clarification requested for the primary voltage rating of the Distribution Transformers, initially indicated as 13,200/76250 V.	The correct primary voltage rating is 13,200/7620 V.
It was asked if the Steel Poles will have markings.	The name "ALECO" will be marked above ground level.
It was asked if with socket type or without socket type for the Clamp Strain.	Clamp Strain, Socket - Type will be required.
It was asked whether stickers, in lieu of embossing, could be used as markings on the transformers to meet the 15-day delivery lead time.	The BAC sternly retains the original requirement of embossed markings; thus, stickers shall not be allowed.

It was asked whether the awarding is per lot basis since in Lot 4, kwHr meters were included.

The BAC resolved to remove the 3,000 units of kWh Meters from Lot 4. Consequently, the **ABC** for Lot 4 will be adjusted to **Php12,193,784.50**.

- d. The Revised Checklist of Eligibility Requirements is heretoattached. The Eligibility, Technical, and Financial Proposals must be properly tabbed for easy reference and must be submitted in sequence/order per Revised Checklist of Requirements.

### **LEGAL DOCUMENTS: Folder 1**

- 1. DTI business name registration/SEC registration certificate, whichever is appropriate under laws of the Philippines;
- 2. Valid and current Mayor's permit/municipal license; (principal place of business)
- 3. BIR Value Added Tax registration;
- 4. Omnibus Sworn Statement- Affidavit (FORM 2)
- 5. Compliance with E.O. #398
  - a. Proof of VAT payments for the past six months.
  - b. Tax Clearance from the BIR to prove bidder's full and timely payment of taxes to the government
  - c. A Certification under oath from the bidder's full responsible officers that the bidder is free and clear of all liabilities with the government.

#### **TECHNICAL DOCUMENTS: Folder 2**

- 1. Statement in matrix form all ongoing and completed government and private contracts (service contracts, maintenance contracts, purchase orders, job orders, etc.) within the relevant period, where applicable, including contracts awarded but not yet started, if any. The statement shall state whether each contract is:

    - i. The name of the contract;
    - ii. Date of contract;
    - iii. Amount of contract and value of outstanding contracts;
    - iv. Date of delivery;

The prospective bidder's computation for its Net Financial Contracting Capacity (NFCC) should be equal or more than the ABC, or a commitment from a universal or commercial bank extend to it a credit line if awarded the contract to be bid, in an amount not lower than the amount set by the procuring entity, which shall be at least equal to ten percent (10%) of the Approved Budget for the Contract (ABC) to be bid.
