2		Those who have already submitted their eligibility requirements may have the option to modify their financial proposal, specifically their bid offer. Those who cannot submit in person may opt to submit the same via express mail. However, bidders should ensure its timely receipt by the BAC, hence, should the BAC receive the envelope after the deadline, the BAC will no longer accept or consider the same.
