## INVITATION TO BID RELAUNCH OF PROCUREMENT OF SERVICE VEHICLE

1. The Tablas Island Electric Cooperative, Inc. through Bids and Awards Committee (BAC) invites interested bidders to participate in the bidding for the following:

Being the Approved Budget of the aforesaid item. Bids received in excess of the ABC for the said lot shall be automatically rejected at the bid opening.

2. TIELCO now invites bids for the above enumerated lots on the **Procurement of Service Vehicles**. The delivery of the vehicles is required within thirty (30) calendar days from receipt of the Notice to Proceed (NTP) and Purchase Order (PO) and shall be delivered Free on Board (FOB) Manila area. The description of the eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the “Government Procurement Reform Act” and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from TIELCO Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below or via BAC official email address [tielco\\_pbac@yahoo.com](mailto:tielco_pbac@yahoo.com) during **Monday to Friday from 8:00 AM to 5:00 PM, Philippine Standard Time, except Holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders from June 20 (office hours 8:00 AM to 5:00 PM) until July 3, 2024 at 12:00 NN, Philippine Standard Time from the address below and upon payment of a non-refundable fee stated above.

6. TIELCO will hold a Pre-Bid Conference on July 3, 2024 at 1:30 PM, Philippine Standard Time at the TIELCO Main Office, Dapawan, Odiongan, Romblon, which shall be open to prospective bidders. Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring entity's requirement. Non-attendance of the Bidder will in no way prejudice its bid, however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/ Bid Bulletin.
7. Bids must be duly received by the BAC Secretariat at the address below on or before July 18, 2024, at 9:30 AM, Philippine Standard Time. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 17.


