- 6. Compliance with EO #398:
  - a. Proof of VAT payment for the past six months and
  - b. Tax clearance from BIR for the last two quarters.
- 7. On-going, completed or awarded contract not yet started within the relevant period specifying the following:
  - a. Name of the contract,
  - b. Date of the contract,
  - c. Amount of contract and value of outstanding contracts,
  - d. Date of Delivery and
  - e. End-user's acceptance if completed.
