3. Prospective Bidders with records of unjustifiable delay in delivery of materials are not allowed to participate in this bidding.

All bids must be accompanied by a Bid Security equivalent to 2% of the Approved Budget for the Contract (ABC) per lot in the form of cash, Cashier's Check, Bank Draft, or Manager's check payable to MARELCO, or Bank Guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank.
