RESOLUTION NO. 115-S. 2024

(Competitive Bidding)

RECOMMENDING AWARD TO MULTI-FOLD LINKS, INC. FOR THE INSTALLATION AND CONFIGURATION OF 200 LICENSES OF LAN MONITORING APPLICATION SYSTEM AND MAINTENANCE SOFTWARE

WHEREAS, the National Electrification Administration-Bids and Awards Committee (NEA-BAC) for Local and In-House Procurement conducted a Competitive Bidding for the project, "Installation and Configuration of 200 Licenses of LAN Monitoring Application System and Maintenance Software" with an Approved Budget for the Contract of Three Million Pesos (₱3,000,000.00) chargeable against the FY 2024 Corporate Operating Budget;

WHEREAS, on 19 July 2024, the Invitation to Bid¹ for the project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the NEA official website, and the bulletin board located at the Ground Floor of the NEA Building;

WHEREAS, only one (1) prospective bidder, namely: MULTI-FOLD LINKS, INC. attended the Pre-Bid Conference on 29 July 2024;

WHEREAS, Supplemental/Bid Bulletin No. 24-03² was issued on 31 July 2024, to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on 12 August 2024, only one (1) bidder, MULTI-FOLD LINKS, INC., submitted a bid;

WHEREAS, after preliminary examination³ of the bid, the NEA-BAC, using non-discretionary "pass/fail" criteria, determined the submission of MULTI-FOLD LINKS, INC. as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by the bidder, using non-discretionary criteria⁴, as stated in the Bidding Documents, it was determined that the submission passed the criteria for post-qualification⁵;

WHEREAS, Section 36 of the 2016 Revised IRR of RA No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements;

NOW, **THEREFORE**, for and in consideration of the foregoing premises, the NEA-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of MULTI-FOLD LINKS, INC. for the project, "Installation and Configuration of 200 Licenses of LAN Monitoring Application System and Maintenance Software" in the amount of Two Million Nine Hundred Seventy-Eight Thousand Pesos (₱2,978,000.00) as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 revised IRR of R.A. No. 9184; and
- 2) To recommend to the NEA Administrator, pursuant to RB Resolution No. 2020-74, that the contract for the project be awarded to **MULTI-FOLD LINKS, INC.** in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR;
- 3) To request for the approval and signature of the NEA Administrator, pursuant to RB Resolution No. 2020-74 on the Notice of Award⁶ in favor of MULTI-FOLD LINKS, INC. for the Installation and Configuration of 200 Licenses of LAN Monitoring Application System and Maintenance Software in the abovementioned amount.
