RESOLUTION NO. 111-S. 2024 (Competitive Bidding)

RECOMMENDING AWARD TO TOYOTA ALABANG INC. FOR LOT A - BRAND NEW TWO (2) UNITS OF MULTI-PURPOSE VEHICLES A COMPONENT LOT IN THE PROCUREMENT OF THREE (3) UNITS OF MOTOR VEHICLES (REBIDDING)

WHEREAS, the National Electrification Administration-Bids and Awards Committee (NEA-BAC) for Local and In-House Procurement conducted a Competitive Bidding for the Project, "Procurement of Three (3) Units of Motor Vehicles (Lot A – Brand New Two (2) Units of Multi-Purpose Vehicles" with an Approved Budget for the Contract of Three Million Six Hundred Thousand Pesos (₱3,600,000.00) chargeable against the FY 2024 Corporate Operating Budget for Capital Outlay;

WHEREAS, on 17 July 2024, the first Invitation to Bid¹ for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the NEA official website, and the bulletin board located on the Ground Floor of the NEA Building;

WHEREAS, Supplemental/Bid Bulletin No. 24-02² was issued on 25 July 2024, to reschedule the Pre-Bid Conference and the Submission and Opening of Bids due to typhoon "Carina";

WHEREAS, no prospective bidder(s) attended the Pre-Bid Conference held on 25 July 2024;

WHEREAS, Supplemental/Bid Bulletin No. 24-05³ was issued on 31 July 2024, to clarify, modify or amend items in the Bidding Documents;

WHEREAS, on August 12, 2024, during the Receipt and Opening of Bids only one (1) bidder, Toyota Silang Cavite Inc. submitted a bid, and was rated "failed" for failure to submit a valid Philgeps Registration, hence, Lot A – a failure of bidding was declared;

WHEREAS, on 20 August 2024, the second Invitation to Bid for the Rebidding of Lot A⁴ was issued and posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the NEA official website, and the bulletin board located on the Ground Floor of the NEA Building;

WHEREAS, three prospective bidders namely: 1) TOYOTA OTIS INC., 2) TOYOTA PASONG TAMO INC. and 3) TOYOTA ALABANG INC. attended the Pre-Bid Conference held on 28 August 2024;

WHEREAS, Supplemental/Bid Bulletin No. 24-06⁵ was issued on 30 July 2024, to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the receipt and opening of bids on 12 August 2024, only one (1) bidder, TOYOTA ALABANG, INC., submitted a bid for Lot A;

WHEREAS, after preliminary examination⁶ of the bid, the NEA-BAC, using non-discretionary “pass/fail” criteria, determined the submission of Toyota Alabang, Inc. as “passed” for complying with all the eligibility and technical requirements⁷ as stated in the Bidding Documents;

WHEREAS, on 24 September 2024, after verification, validation, and ascertainment of all statements made and documents submitted by Toyota Alabang, Inc., using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of Toyota Alabang, Inc. passed the criteria for post-qualification⁸;

WHEREAS, Section 36 of the 2016 Revised IRR of RA No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements;

NOW, THEREFORE, for and in consideration of the foregoing premises, the NEA-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of TOYOTA ALABANG, INC. for the Project, “Lot A - Procurement of Brand New Two (2) Units of Multi-Purpose Vehicle a Component Lot in the Procurement of Three (3) Units of Motor Vehicles (Rebidding)” in the amount of Three Million Six Hundred Thousand Pesos (₱3,600,000.00) as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 revised IRR of R.A. No. 9184; and
- 2) To recommend to the NEA Administrator, pursuant to RB Resolution No. 2020-74, that the contract for the Project be awarded to TOYOTA ALABANG INC. in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR;
- 3) To request for the approval and signature of the NEA Administrator, pursuant to RB Resolution No. 2020-74 on the Notice of Award⁹ in favor of TOYOTA ALABANG INC. for the Procurement of Brand New Two (2) Units of Multi-Purpose Vehicle a Component Lot in the Procurement of Three (3) Units of Motor Vehicles (Rebidding) in the above-mentioned amount.
