### RESOLUTION NO. 113-S. 2024 (Competitive Bidding)

#### RECOMMENDING THE AWARD TO NISSAN COMMONWEALTH INC. FOR PROCUREMENT OF THREE (3) UNITS OF MOTOR VEHICLES (REBIDDING): LOT B – BRAND NEW ONE (1) UNIT OF PASSENGER VAN

**WHEREAS**, the National Electrification Administration-Bids and Awards Committee (NEA-BAC) for Local and In-House Procurement conducted a Competitive Bidding for the Project, "Procurement of Three (3) Units of Motor Vehicles (Rebidding)" with an Approved Budget for the Contract stated below chargeable against the FY 2024 Corporate Operating Budget for Capital Outlay:

**WHEREAS**, on 17 July 2024, the first Invitation to Bid<sup>1</sup> for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the NEA official website, and the bulletin board located on the Ground Floor of the NEA Building;

**WHEREAS**, Supplemental/Bid Bulletin No. 24-02<sup>2</sup> was issued on 25 July 2024, to clarify, modify or amend items in the Bidding Documents particularly the schedule of the Pre-Bid Conference and the Receipt and Opening of Bids due to typhoon Carina;

**WHEREAS**, during the Pre-Bid Conference on 29 July 2024, only one (1) prospective bidder attended for Lot B namely: NISSAN COMMONWEALTH INC.;

**WHEREAS**, Supplemental/Bid Bulletin No. 24-05<sup>3</sup> was issued on 31 July 2024, to clarify, modify or amend items in the Bidding Documents;

**WHEREAS**, during the receipt and opening of bids on 12 August 2024, no bidder submitted a bid for Lot B;

**WHEREAS**, Section 35.1 of the 2016 Revised IRR of R.A. 9184 provides, that the BAC shall declare the bidding a failure when: a) No bids are received; hence, a first failure of failure of bidding was declared;

**WHEREAS**, on 20 August 2024, the second Invitation to Bid<sup>4</sup> for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the NEA official website, and the bulletin board located on the Ground Floor of the NEA Building;

**WHEREAS**, during the Pre-Bid Conference on 28 August 2024, no prospective bidder attended for Lot B;

**WHEREAS**, during the receipt and opening of bids on 09 September 2024, one (1) bidder, namely: NISSAN COMMONWEALTH INC. submitted a bid for Lot B;

**WHEREAS**, after preliminary examination<sup>5</sup> of the bid, the NEA-BAC, using non-discretionary “pass/fail” criteria, determined the submission of NISSAN COMMONWEALTH INC. as “passed” for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

**WHEREAS**, after verification, validation, and ascertainment of all statements made and documents submitted by NISSAN COMMONWEALTH INC. using non-discretionary criteria<sup>6</sup>, as stated in the Bidding Documents, it was determined that the submission passed the criteria for post-qualification<sup>7</sup>;

**WHEREAS**, Section 36 of the 2016 Revised IRR of RA No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the NEA-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of **NISSAN COMMONWEALTH INC.** for the project, “**Procurement of Three (3) Units of Motor Vehicles (Rebidding): Lot B – Brand New One (1) Unit of Passenger Van**” in the amount of **One Million Five Hundred Ninety-Eight Thousand Eight Hundred Eighty-Eight Pesos (₱1,598,888.00)** as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 revised IRR of R.A. No. 9184; and
- 2) To recommend to the NEA Administrator, pursuant to RB Resolution No. 2020-74, that the contract for the project be awarded to **NISSAN COMMONWEALTH INC.** in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR;
- 3) To request for the approval and signature of the NEA Administrator, pursuant to RB Resolution No. 2020-74 on the Notice of Award<sup>8</sup> in favor of **NISSAN COMMONWEALTH** for the **Procurement of Three (3) Units of Motor Vehicles (Rebidding): Lot B – Brand New One (1) Unit of Passenger Van** in the above-mentioned amount.
