RESOLUTION NO. 114-S. 2024 (Competitive Bidding)

RECOMMENDING AWARD TO APDS AUTOMATION AND POWER DISTRIBUTION SERVICES FOR THE SUPPLY, INSTALLATION, REPLACEMENT, TESTING AND COMMISSIONING OF AUTOMATIC TRANSFER SWITCH (ATS) WITH BYPASS AND ISOLATION SWITCH (BP/IS) AND LOW VOLTAGE SWITCHGEAR (LVSG)

WHEREAS, the National Electrification Administration-Bids and Awards Committee (NEA-BAC) for Local and In-House Procurement conducted a Competitive Bidding for the Project, "**Supply, Installation, Replacement, Testing and Commissioning of Automatic Transfer Switch (ATS) with Bypass and Isolation Switch (BP/IS) and Low Voltage Switchgear (LVSG)**" with an Approved Budget for the Contract of Six Million Five Hundred Twenty Thousand Pesos (₱6,520,000.00) chargeable against the FY 2024 Corporate Operating Budget;

WHEREAS, on 19 July 2024, the Invitation to Bid¹ for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the NEA official website, and the bulletin board located at the Ground Floor of the NEA Building;

WHEREAS, only one (1) prospective bidder, namely: APDS AUTOMATION AND POWER DISTRIBUTION SERVICES attended the Pre-Bid Conference on 29 July 2024;

WHEREAS, Supplemental/Bid Bulletin No. 24-04² was issued on 31 July 2024, to clarify, modify or amend items in the Bidding Documents;

WHEREAS, during the submission and opening of bids on 12 August 2024, only one (1) bidder, APDS AUTOMATION AND POWER DISTRIBUTION SERVICES, submitted a bid;

WHEREAS, after preliminary examination³ of the bid, the NEA-BAC, using non-discretionary "pass/fail" criteria, determined the submission of APDS as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by APDS, using non-discretionary criteria⁴, as stated in the Bidding Documents, it was determined that the submission of APDS passed the criteria for post-qualification⁵;

WHEREAS, Section 36 of the 2016 Revised IRR of RA No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements;

NOW, THEREFORE, for and in consideration of the foregoing premises, the NEA-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of **APDS AUTOMATION AND POWER DISTRIBUTION SERVICES** for the project, “**Supply, Installation, Replacement, Testing and Commissioning of Automatic Transfer Switch (ATS) With Bypass and Isolation Switch (BP/IS) AND Low Voltage Switchgear (LVSG)**” in the amount of **Six Million Four Hundred Seventy-Eight Thousand Eight Hundred Three Pesos and Eighty-Eight Centavos (P6,478,803.88)** as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 revised IRR of R.A. No. 9184; and
- 2) To recommend to the NEA Administrator, pursuant to RB Resolution No. 2020-74, that the contract for the Project be awarded to **APDS AUTOMATION AND POWER DISTRIBUTION** in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR;
- 3) To request for the approval and signature of the NEA Administrator, pursuant to RB Resolution No. 2020-74 on the Notice of Award⁶ in favor of **APDS AUTOMATION AND POWER DISTRIBUTION** for the **Supply, Installation, Replacement, Testing And Commissioning of Automatic Transfer Switch (ATS) With Bypass and Isolation Switch (BP/IS) AND Low Voltage Switchgear (LVSG)** in the above-mentioned amount.
