RESOLUTION NO. 69-S. 2024

(Competitive Bidding)

Recommending Award of Petawealth Gasoline Station for the Procurement of Fuel, Oil, Lubricants, and Other Services for NEA Vehicles (Re-Bidding)

WHEREAS, on 03 January 2024, the Technical Working Group (TWG) endorsed to the Bids and Award Committee (BAC) the Technical Specifications for the Procurement of Fuel, Oil, Lubricants, and Other Services for NEA Vehicles (Re-Bidding);¹

WHEREAS, the General Services Division prepared the Purchase Request No. 24-01-002 dated 16 January 2024 for the bidding of the above procurement;²

WHEREAS, the Approved Budget for the Contract (ABC) for the aforesaid procurement amounting to Four Million Pesos (₱4,000,000.00) for the Procurement of Fuel, Oil, Lubricants, and Other Services for NEA Vehicles was certified available by the Corporate Resources and Financial Services of NEA, chargeable against the MOOE under Gasoline, Oil and Lubricants of FY2024 Annual Procurement Plan (APP);³

WHEREAS, the following bidding activities for the aforesaid procurement were conducted by the BAC, as follows;

On 05 February 2024, the BAC declared the 1st FAILURE OF BIDDING as per BAC Resolution No. 7 and recommended to the HoPE the RE-BIDDING as per Section 35 of the 2016 Revised IRR of RA 9184;4

On 26 April 2024, the **Invitation to Bid** for the above-mentioned procurement was posted/published on the PhilGEPS, NEA website, and conspicuous place, in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;⁵

On 06 May 2024, the **Pre-Bid Conference** was conducted at the Cultural Affairs Room, 2nd Floor, NEA Bldg., which was participated by the BAC, Technical Working Group (TWG), BAC-Secretariat and one (1) prospective bidder, namely: Petawealth Gasoline Station;⁶

On 16 May 2024, during the **Submission of Bids**, Petawealth Gasoline Station submitted their bids;⁷

On the same date, the Opening of Bids was conducted face to face which was participated by the BAC, TWG, BAC Secretariat, and Petawealth Gasoline Station:8

The submitted technical component envelope of the bidder consisting of legal, technical, and financial documents, was opened and passed the preliminary evaluation by the BAC using the non-discretion "pass/fail" criterion; 9

Having complied with the preliminary evaluation of the technical components, the financial bid component was subsequently opened, yielding the financial bid amount which is within the ABC of Four Million Pesos (PhP4.000.000.00) as follows:10

By virtue of BAC Resolution Nos. 53-S.2023 and 57-S.2023, respectively, the BAC directed the TWG to conduct the bid evaluation and post-qualification of the bids submitted by the bidder pursuant to Sections 32 and 34 of the 2016 Revised IRR of RA 9184;11

On 17 May 2024, the TWG submitted its Bid Evaluation Report declaring Petawealth Gasoline Station as the Single Calculated Bidder for the Procurement of Fuel, Oil, Lubricants, and Other Services for NEA Vehicles for the aforesaid procurement and thereby recommended for postqualification;12

On 23 May 2024, the BAC sent the Notice of Post-Qualification to Petawealth Gasoline Station for the Procurement of Fuel, Oil, Lubricants, and Other Services for NEA Vehicles. Thereafter, Petawealth Gasoline Station submitted the required post-qualification documents within the required period of five (5) days;13
