### **CONTRACT AGREEMENT**

# PROCUREMENT OF SYSTEMS INTEGRATION SERVICES FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF THE NEA DIGITAL DASHBOARD COMMAND CENTER (DDCC) - PHASE 2

THIS AGREEMENT made the \_\_\_\_ day of \_\_\_\_ 2024 between NATIONAL ELECTRIFICATION ADMINISTRATION of 57 NIA Road, Barangay Pinyahan, Dlliman, Quezon City, Philippines (hereinafter called "the Entity") of the one part and 1DOCUMENT CORPORATION of 2/F Royal Mall Zone, Bayambang, Pangasinan, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Systems Integration Services for the Supply, Delivery, Installation and Commissioning of the NEA Digital Dashboard Command Center (DDCC) - Phase 2 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Ninety Million Three Hundred Sixty Thousand Pesos (\$\pm\$90,360,000.00) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications:
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Ninety Million Three Hundred Sixty Thousand One Hundred Pesos (₱90,360,000.00) or such other sums as may be ascertained, 1Document Corporation agrees to Integration Services for the Supply, Delivery, Installation and Commissioning of the NEA Digital Dashboard Command Center (DDCC) Phase 2 in accordance with his/her/its Bid.
