



INVITATION TO BID

Procurement of Systems Integration Services for the Supply, Delivery, Installation and Commissioning of the NEA Digital Dashboard Command Center (DDCC) - Phase 2

1. The *National Electrification Administration (NEA)*, through the *GAA CY 2024 Corporate Operating Budget (COB)*, intends to apply the sum of *Ninety Million Six Hundred Thirty-Seven Thousand One Hundred Sixteen Pesos & 49/100 (₱90,637,116.49)* being the ABC to payments under the contract for *Procurement of Systems Integration Services for the Supply, Delivery, Installation and Commissioning of the NEA Digital Dashboard Command Center (DDCC) - Phase 2/ NEA DDCC2-2024-01*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *NEA* now invites bids for the above Procurement Project. Delivery of the Goods is required by *six (6) months duration of the Contract which will commence within seven (7) calendar days upon receipt of Notice to Proceed (NTP)*. Bidders should have completed, within *ten (10) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from *National Electrification Administration* and inspect the Bidding Documents during *8:00 A.M. to 5:00 P.M., Monday to Friday*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *30 November 2024* from the given address and website/s below, upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *₱50,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.


