Instruction to Bidders - Eligible Bidders – Clause 5.2</b></p> <p><i>The Bidder must have an experience of having completed a Single Largest Completed Contract (SLCC) that is similar to this Project, <b>equivalent to at least fifty percent (50%) of the total ABC for Lots 1 and 2 (Php281,553,397.00)</b> adjusted, if necessary, by the Bidder to current prices using the PSA’s CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184.</i></p>
