FOR PALAWAN ELECTRIC COOPERATIVE 40MW BASELOAD SUPPLY AND 15MW PEAKING SUPPLY OF POWER FOR THE PALAWAN MAIN GRID

In relation to the *Bidding Procedures (II-01 Schedule of Bidding Activities)* for the Competitive Selection Process conducted by the National Electrification Administration (NEA) for Palawan Electric Cooperative's (PALECO) 40 MW baseload supply and 15MW peaking supply of power for the Palawan Main Grid, the NEA-Special Bids Awards Committee (NEA-SBAC) hereby issues Bid Bulletin No. 4.
