- Pursuant to Sections 2 (b) and (c) of Republic Act No. 9136, otherwise known as the *Electric Power Industry Reform Act of 2001* (EPIRA) and in compliance with the jurisdictional requirements of the Department of Energy (DOE) as expressed in Department Circular No. DC2023-06-0021 and the mechanism of the Energy Regulatory Commission as provided in the *Implementing Guidelines for the Procurement, Execution, and Evaluation of Power Supply Agreements Entered into by Distribution Utilities for the Supply of Electricity to their Captive Market* and upon receipt of the **Certificate of Conformity (NEA-RAO-COC-2024-08)** issued on **29 JULY 2024**, the Oriental Mindoro Electric Cooperative, Inc. (ORMECO, Inc.) Special Party Bids and Awards Committee (SBAC) hereby publishes this Invitation to Bid, to conduct a **Competitive Selection Process (CSP)** for the construction, installation, operation, and maintenance of power plants for the **57-MW Guaranteed Dependable Capacity (GDC) Power Supply**;
